**Determination of the Challenges to Petitions  
2025 General Election  
by the Office of the Camden County Clerk**

On June 13, 2025, Dennis Pfeill made objections to the petition of Keith Gibbons for Gloucester Township Mayor and the petition of Nicholas J. Rehrig, Jennifer O'Donnell, and Arnaldo Torres for Members of Gloucester Township Council.

On June 15, 2025, Raymond Polidoro made objections to the petition of Joesph Brocco for Gloucester Township Mayor.

On June 16, 2025, Keith Gibbons made objections to the petition of Joesph Brocco for Gloucester Township Mayor.

The County Clerk's Office has reviewed the objections to the petitions and has made the following determinations:

**Petition of Keith Gibbons for Gloucester Township Mayor**

- The petition was accepted with 409 signers.
- After a review of the challenged signers to the petitions, it has been determined that there are 379 valid signatures. The required number of signatures is 250. As such, this petition is determined to be valid.

**Petition of Nicholas J. Rehrig, Jennifer O'Donnell, and Arnaldo Torres for Members of Gloucester Township Council**

- The petition was accepted with 360 signers.
- After a review of the challenged signers to the petitions, it has been determined that there are 347 valid signatures. The required number of signatures is 250. As such, this petition is determined to be valid.

**Petition of Joesph Brocco for Gloucester Township Mayor**

- The petition was accepted with 327 signers.
- After a review of the challenged signers to the petitions, it has been determined that there are 244 valid signatures. The required number of signatures is 250. As such, this petition is determined to not be valid.


In summary, for the 2025 General Election:
